2. Candidate are required to bring following documents for verification in original and a copy each of:

- a. High School Certificate (Proof of Date of Birth) and High School Marksheet
- b. Certificate of Intermediate Examination and Marksheet (If Applicable)
- c. Certificate/ All Mark sheets of B. Tech/Diploma/Intermediate/High School

-In case, Certificate is not Awarded, Provisional Certificate awarded by the Head of Institution/VC shall be required to be produced.

-Certificate (by Principal/Director/Dean(Academics)/Registrar of the University /Board) for Equivalent percentage of the Final CGPA in the qualifying examination, in case final result is declared in CGPA.

- d. Caste Certificate/PH Certificate (If Applicable)
- e. Candidates applied under Economically Weaker Section (EWS) category will have to produce Income and Assets certificate as per Govt. Of India rules (format enclosed) issued by the competent authority like District Magistrate/Additional District Magistrate/Sub Divisional Magistrate/Revenue Officer of the rank not below the level of Tehsildar
- f. Copy of the HAL Application for Degree/Diploma Apprenticeship 2023.

3. Candidates will be given provisional offer for apprenticeship and related instructions subject to satisfactory verification of original documents of applicant in accordance with Apprentices Act (1961) amended from time to time, Requirements stipulated in the advertisement, rules/guidelines of BOAT in vogue as on date of verification and correctness of MHRD NATS registration vis a vis application submitted by the applicant. Attending Candidates are required to follow government COVID guidelines and COVID appropriate behaviour

4. No TA/DA will be payable for attending Document Verification.

5. Candidates not attending document verification will be considered not interested and candidature deemed rejected.

6. Apprenticeship engagement is for one year training only as per Apprentices Act 1961 and there is no provision of job after training whatsoever.
