Salient features of the Direct Recruitment Process for filling up of the posts of Technician/B in the Level 3 of the Pay Matrix in Directorate of Construction, Services & Estate Management against Advertisement No. DCSEM/01/2022.

An advertisement was issued for 20 posts of Technician/B in six disciplines, vide Advt. No. DCSEM/01/2022. Last date of receipt of applications was 29th April, 2022. As per the methodology for selection to the post, selection has to be made in 3 stages (Stage-I-Preliminary Test / Stage-II-Advanced Test / Stage-III-Skills Test).

Accordingly, Screening tests for the posts of Technician/B were conducted on 18th September, 2022. Tests were conducted in two stages, Stage-1 (Preliminary test) and Stage-2 (Advanced test) on the same day. Candidates qualified in Stage-1 were called for Stage-2. Candidates qualified in Stage-2 were called for Stage-3 (Trade/skills test) in the ratio of 1:5.

Trade/skills test was conducted on 10th, 11th, 15th and 16th December, 2022. The Trade/skills test was conducted on a Go/No-Go basis for qualifying the candidates. Candidates clearing the Trade/skills Test were shortlisted and empanelled in order of merit based on marks secured in Stage-2.
