- 3) Your training period and stipend will be as per extent rules and directives issued by Railway Board from time to time.
- 4) No Hostel accommodation will be provided and selected candidates will have to make their own arrangement during their training as per Apprentice Act 1961 and they will be released on completion of the training. Imparting Training in Railway will not confer any right to the candidates for their absorption in Railway after completion of Training.
