Applications are invited from ITI qualified Indian citizen (both male / female) in the various designated trades for enrolment into apprenticeship training at Naval Ship Repair Yard, Karwar and Naval Aircraft Yard (Goa), Dabolim, Goa under The Apprentices Act, 1961 read in conjunction with The Apprenticeship Rules, 1992. A total of 180 vacancies for Naval Ship Repair Yard, Karwar and 30 vacancies for Naval Aircraft Yard (Goa), Dabolim, Goa as per distribution shown below are to be filled up:-

advised not to apply for the apprenticeship training due to non-availability of competent instructors/ facility. If applied, the application will be rejected without any further correspondence), **Ex-Serviceman-Children of Armed Force Personnel/Ex-Serviceman and Ex-Serviceman.**

Note:-

- (a) In case candidates qualified less than the vacancies advertised for a certain trade, the vacancies of that trade will be cancelled and re-appropriated to other trades based on the overall merit and category. Post re-appropriation, total no. of vacancies in any trade shall not exceed 30 for NSRY, Karwar.
- (b) In case of any vacancy earmarked for any reservation category cannot be filled up in a enrolment year due to non-availability of suitable candidates in the relevant category of reservation, such vacancies for that particular enrolment year shall not be carried forward to the next enrolment year as backlog.

Note: Qualification for the candidates who are to be enrolled as Crane Operator Overhead (Steel Industry) and Forger & Heat Treater trade shall be 10th Std pass. For Rigger trade, the qualification for the candidates shall be 8th Std pass.

(b) **Age.** Candidates should have completed 14 years and below 21 years of age as on 15 Apr 2025 i.e. born between 15 Apr 2004 and 14 Apr 2011 (both dates inclusive). The upper age limit of 21 years is relaxable by five (05) years in the case of candidates belonging to Scheduled Castes (SC) / Scheduled Tribes (ST). The upper age limit may be further relaxed by two (02) years by Naval Headquarters at their discretion in respect of candidates who merit special consideration.

(c) **Physical Standards.** Height 150 Cms, Weight not less than 45 Kgs, Chest expansion not less than 5 cm, Eye sight 6/6 to 6/9 (6/9 corrected with glasses), external and internal organs to be normal.

(d) **Previous Training.** Apprenticeship is a onetime opportunity to the candidates. Candidates who have already undergone or undergoing apprenticeship training under Apprentices Act, 1961 in any other Govt. / Public Sector / Private Industrial Organization are not eligible to apply.

3. Reservation.

(a) **For SC/ ST.** Vacancies for SC/ ST candidates are reserved in accordance with Section 3A(1) & (2) of Chapter II of Apprentices Act, 1961 read in conjunction with Schedule IIA of Rule 5 of Apprenticeship Rules, 1992, provided when the prescribed number of persons belonging either to the Scheduled Castes or to the Scheduled Tribes are not available, the training places so reserved for them may be filled by persons belonging to the Scheduled Tribes or as the case may be to the Scheduled Castes and if the prescribed training places cannot be filled even in the above given manner then the training places so lying unfilled may be filled by persons not belonging to the Scheduled Castes or the Scheduled Tribes.

(b) **For OBC.** Vacancies for OBC candidates are reserved in accordance with Section 3B(1) & (2) of Chapter II of Apprentices Act, 1961 and Press Information Bureau/ Govt of India/ Ministry of Social Justice and Empowerment Press Release dated 14 Aug 14. If vacancies in Other Backward Classes cannot be filled from the OBC, then the vacancies so lying unfilled may be filled by candidates not belonging to the Other Backward Classes.

(c) **For Person with Benchmark Disabilities (PwBD).** 3% of overall vacancies for apprenticeship training are reserved as per Section 3.6.2 of Chapter III of Apprenticeship Training Manual and PwBD Act, 1995. In order to avail PwBD reservation, the percentage of disability should not be less than 40% and relevant latest valid certificate issued by medical board by any Govt. Hospital to be submitted.

(d) **For Children of Armed Force Personnel/ Ex-Serviceman.** 3% of overall vacancies for apprenticeship training are reserved as per Section 3.6.3 of Chapter III of Apprenticeship Training Manual.

4. Stipend. The minimum rate of stipend payable to apprentices per month shall be as per the qualifications stipulated in the curriculum. The minimum rate of stipend payable to apprentices per month shall be follows, namely (Rule 11 of Apprenticeship Rules, 1992 is relevant):-

5. How to Apply. Interested eligible candidates are required to register online on www.apprenticeshipindia.gov.in. The under mentioned procedure is to be followed for registration at apprenticeship web portal under National Apprenticeship Promotion Scheme (NAPS):-

(a) **Before starting the process of registration, candidate must ensure that name, date of birth and father name in Aadhar Card must be matching with of SSC**

certificate. Otherwise, change the details in Aadhar Card according to the SSC certificate (For Rigger, 8th Std certificate).

(b) Log on to www.apprenticeshipindia.gov.in web portal. Then home page of the website would open.

(c) Click on Candidate Login/ Register module in the home page. A page titled Candidate Registration would open. The candidate is required to fill up his personal details, contact details in the form and then submit the application by clicking the submit option.

(d) Post submission of application a system generated auto mail would be sent to the e-mail ID for profile activation. Candidates have to activate their profile.

(e) Go back to Home page of www.apprenticeshipindia.gov.in. Click on Candidate Login/ Register module in the home page. To open profile, candidates have to enter his/ her registered E-mail ID, then click submit. OTP would be sent to the registered mobile number for authentication.

(f) Post login, candidates have to enter their personal details like date of birth (upload only 10th Std mark sheet or Birth Certificate issued by competent authority as date of birth proof), father name, mother name and address, add educational qualifications (only 10th Std & ITI), trade preference, bank account details and validate Aadhar Number.

(g) On completion of candidate profile, the candidates are required to follow steps online for registration in www.apprenticeshipindia.gov.in web portal:-

- (i) **Step 1:** Log on to www.apprenticeshipindia.gov.in web portal.
- (ii) **Step 2:** Click Apprenticeship Opportunities from dropdown menu (top right corner)
- (iii) **Step 3:** Enter "NAVAL SHIP REPAIR YARD, KARWAR" in "Search by Establishment Name" section. A list of Opportunities would be displayed.
- (iv) **Step 4:** Click Apply for the desired/ eligible apprenticeship trade from the list of Opportunities.
- (v) **Step 5:** Select "Uttara Kannada"
- (vi) **Step 6:** Click "Ok".

6. Selection Procedure. Preliminary selection will be made on the basis of marks obtained in Matric & ITI examination and age. Candidates in the Preliminary Merit list will be called for **written examination scheduled to be held at Karwar in Jan 2025.**

A call letter for written examination will be issued to all eligible candidates on their registered email ID. Written examination would be objective type based on Mathematics (20), General Science (20) and General Knowledge (10), with each question carrying one and half marks for a duration of one hour. There will be No negative marking. The question paper will be bilingual both English and Hindi. A merit list shall be prepared on the basis of written examination. Candidates in the order of merit would be called for document verification / interview in various trades and applicable reservation categories. Interview is based on technical skills of the candidates in the respective trade. Joining letter will be issued to the selected candidates on their registered email ID. Two separate merit lists will be drawn for two establishments i.e. one for Naval Ship Repair Yard, Karwar and one for Naval Aircraft Yard (Goa).

7. Notices to Prospective Candidates. In case of any change in schedule of dates, amendment etc., the same will be intimated on the registered email.

8. Travel Expenses. No travel expenses are admissible for candidates called for written examination. Only those candidates called for document verification / interview and failed to qualify the same will be paid second class train fare from home / journey station to Karwar on production of original railway / bus ticket.

9. Boarding/ Lodging. No accommodation will be provided to candidates by NSRY (Kar) during entire selection process. Candidates called for written examination/ interview are to arrange their own boarding and lodging.

10. Medical Examination. Selected candidates shall undergo medical examination through District Hospital and declared fit as per Rule 4 and Schedule II of Apprenticeship Rules, 1992. Candidates would be required to produce medical fitness certificate in the format provided by Naval Ship Repair Yard, Karwar duly signed by the District Hospital Surgeon not below the rank of Asst. Surgeon, at the time of joining.

11. Police Verification Certificate. Candidates would be required to produce Police Verification Certificate during joining.

12. Commencement of Training/ Apprenticeship Contract. Finally, selected candidates shall be offered apprenticeship contract as per the Apprentices Act, 1961 and they are to join Dockyard Apprentice School (DAS), Naval Ship Repair Yard, Karwar/ Apprentice Training School (ATS), Naval Aircraft Yard (Goa), Dabolim, Goa on the mentioned date (**likely to be on 14 Apr 2025**).
